## Admission Rules

1. Admission is based on prescribed rules as stated by state Government and University/B.C.I. Application form to be submitted in proper time. Admission will not be given after the stipulated time period.
2. Following self-attested documents to be attached along with the admission form:
  - a. Marksheet of each semester/year passed examination
  - b. Transfer Certificate
  - c. Migration Certificate
  - d. Caste Certificate (EWS/OBC/SC/ST/Minority) if required
  - e. Income Certificate (For Scholarship/E.W.S.) if required
3. Admission is valid only on submission of prescribed fees with application form.
4. The Principal has the right to reject any application without giving any reason.
5. The signature of student/ parents/guardian is mandatory on application form.
6. The college can resort any action against student, if conduct of any student is found objectionable or on violation of any college rules.
7. Admission criteria is solely on the basis of merit.
8. The fees deposited is not refundable or transferable in any circumstances.
9. After confirmation of the admission by the institution, the admission fee will be deposited through online mode by the applicant.
10. The students must keep their College ID Card when they will come in college campus.
11. The students must wear proper Uniform in college campus.
